VI continues to monitor the Centers for Disease Control and adheres to local and federal government mandates regarding the novel coronavirus (COVID-19).

- You may always cancel at greater than 30 days in advance of a check-in date, for a full refund of your VI Points.
- Due to the pandemic, we will continue to waive cancellation restrictions for those traveling through July 31, 2020, or to reservations at a VI Resort which is closed due to government mandate (see full list of closures below). If your reservation used VI Points that have an expiration date of 6/30/2020, VI will extend those points to use for travel completed by 6/30/2021.
- As of August 1, 2020, any reservations that are cancelled will follow the VI cancellation policy of 30 days in advance for a full refund of points.
- Rental specials and exchange reservations cannot be cancelled, changed or refunded.

VI's Hawaii resort locations are open. We are looking forward to welcoming vacationers who have met all requirements for travel to Hawaii without self-quarantine.

The Hawaii Pre-Travel Testing Program begins October 15th. With a negative result of your COVID-19 test within 72 hours of travel, you may bypass the mandatory 14-day quarantine. Upon check-in at the resort, you will be required to show proof of a negative COVID-19 test for each member of your party. You will be required to sign a release of liability.

\* Current state and local mandates do not allow for quarantine at our resort locations in Kauai and Maui. We DO NOT recommend guests to quarantine at our other Hawaii resort locations, as VI Resorts personnel will not be able to assist you during quarantine. The State has mandated that VI, as the host is liable for enforcing the quarantine and reporting violations.

Prior to travel, you will need to register and complete health forms located at <https://travel.hawaii.gov>.

Please note that local activities and tourist attractions may be impacted during your stay, along with Covid-19 protocols that may limit onsite amenities.

Should you wish to cancel your upcoming reservation to Hawaii, you may do so, without any penalty for travel through November 30, 2020. The VI Points used to book the reservation will go back to their original status.
