Reminders

- Units are randomly assigned by computer on the morning of your arrival. No specific request can be taken.
- Mid-stay cleans only occur for stays of more than 9 nights. Additional maid service will be charged at current rates.
- Parking is available for one vehicle per unit during your stay. Larger vehicles are not permitted on property. Parking is near the check-in office but not near the units. The resort has golf carts that are used to take you to your unit.
- Smoking (tobacco or cannabis, including electronic-cigarettes) is prohibited in all VI condos as well as on the lanais, decks and balconies. Where available, a designated smoking area will be provided. A fine will be assessed for non-compliance.
- Pets are not allowed on property. A fine will be assessed for non-compliance.

One Bedroom

Unit Amenities

All units are equipped with a full kitchen, fireplace, cable TV, telephone, Wi-Fi (Free), air conditioning, and lanai. Coin-op laundry is on-site. Shampoo and conditioner are not provided at the resort (in compliance with VI policy). Such small travel toiletries can be purchased at the local stores.

& Unit Access: Due to the age and the structure of the building the resort is not accessible for guests with mobility issues. This resort requires a lot of walking and has many stairs to access the units. Call the front desk to have a golf cart shuttle if needed.


Driving Directions

Location

The resort is located amidst a 35-acre evergreen forest and sits above a stretch of coast discovered by Captain James Cook in 1778. The Inn at Otter Crest is oriented to the sea and surrounded by natural wonders.

From Portland International Airport (PDX)

- Take Interstate 5 South for approximately 60 miles to Exit 260A (the Salem Parkway).
- Follow the Parkway approximately 5 miles to Hwy 22. Here you will see sign saying “To Oregon Coast Beaches”.
- Turn right and stay on Hwy 22 for approximately 40 miles until it merges with Hwy 18.
- Follow Hwy 18 for approximately 28 miles until it intersects with Hwy 101.
- Turn south on Hwy 101 and follow for approximately 22 miles through Lincoln City and Depoe Bay to Otter Rock.
- Take Otter Crest Loop exit and proceed to the resort entrance.



Note: It is very easy to get lost in the Otter Crest area, especially if you are traveling at night. It is very dark, the street signs are small, not easily visible, and the area is not well lit.
